An effective strategy supported by a marketing overkill: beneficiaries sector margins are unimaginable in any other field.-----

The authors dismantle lobbying strategies of "Big Pharma" and focus to conflicts of interest linking the industrial powers to political and health authorities. But above all, they make solid proposals for a fundamental reform of drug policy.-----

Ten billion a year economy euros are possible without keeping the quality of care and equal access for all to treatment. Only a citizen's appropriation of this "common good" what health will rise by a genuine political will to change the system. " Michele Rivasi MEP, biology professor and specialist in public health issues. The co-authors of the book "Racket of pharmaceutical companies and how to get out" are Serge Rader, a pharmacist and whistleblower and, Marie-Odile Bertella-Geffroy who is a former magistrate before becoming a lawyer in 2014, specializing in public health court records.
